3. Public Comment

Nicole Meissner, 310 Union Place - Voiced concerns of issues in the neighborhood. Drafted a letter to all neighbors. Started a private Facebook page for all neighbors to share about concerns. Gave examples of behavior happening in the neighborhood.

Sue Denor, 128 Riverview Dr. - Explained about a public health risk that has happened in the neighborhood.

Tom Denor, 128 Riverview Dr. - Have someone check into some additional lighting in the area as the block is very dark. One street light in the whole block.

Krupski, 138 Riverview Dr. - Explained about the unkept building.

Kevin Carbon, 417 Riverview Dr - These people have no respect for anyone and can't use the sidewalk. They just don't care. They are above and beyond everyone.

Chief Reimer explained about the extra police presence. Citizens encouraged to continue to call the department. Continue to take pictures and videos for evidence. I will give another order to have more of a police presence. Keep the calls coming and call immediately, do not wait. Citizen stated that he is concerned that a child or someone is going to get hurt. Maybe a child is going to get run over as they are dashing into the roadway at all times of the day. Chief Reimer continued to ask for patience and will get help with the process of a nuisance property.
