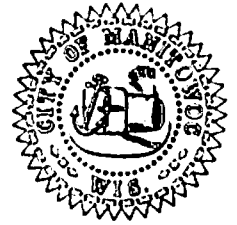

RE: Municipal Code Section 11.010 (12)
"Class B" License Regulations

Recently there was a change in Wis. Stat. 125.51(3)(b) to allow for the sale of intoxicating liquor in the original package or container IN ANY QUANTITY to be consumed off the premise where sold. This relates to "Class B" tavern license holders.

Currently our Municipal Code 11.010(12) allows for the sale of four liters which is what the State law was previously.

The question before your committee is whether or not you want to change the Municipal Code to allow for the sale of intoxicating liquor "in any quantity" or keep the Code as is at "four liters".
