My request to you today is for One Badger Book Server unit and Four Badger Book Client units at a cost of \$9,866.94.

In 2019 CAWG approved and we purchased 25 Badger Books. They have proven to be a useful tool in conducting our elections. We are currently using them at nine of our ten polling locations and Central Count which we implemented for the first time at the April 7, 2020 election. District 4, City Hall, is our least utilized polling place and the Badger Books have not been implemented there because those Badger Books are needed at Central Count to speed up the processing of absentee ballots.

If you will recall, Badger Books are used for voter check in, assigning voter numbers and voter registration at the Polls. At Central Count they assign the voter numbers and process the absentee ballots ten at a time which is a real time saver. After the election, we can upload voter participation and voter registrations into the Wis. Vote system in record time. Something that would have taken staff weeks or even months to do happens in less than two hours. And the best part is there are no incomplete voter registrations which means no phone calls, no letters to voters telling them their registration is incomplete and they will need to re-register the next time they vote. It was also very helpful with the many new pollworkers at the April election because the Badger Books takes them through the process step by step and does not allow for missing information. After the election we can also run a report for the County Clerk of the voter participation.

Having these additional Badger Books would allow for all locations to utilize them and they should each have plenty of Badger Books for the upcoming Presidential election. Initially I thought we could "borrow" additional Badger Books for larger elections until their purchase could fit into the budget, but during the April election, I had issues getting Wis. Elections Commission to commit to borrowing us the needed equipment. I also found out we have to pick them up and drop them off in Madison.
