A tract of land located in the NE 1/4 of the NW 1/4 of Section 18, T.19N., R.24E., City of Manitowoc, Manitowoc County, Wisconsin and described as follows:

Commencing at the North 1/4 corner of said Section 18, thence N88°38'26"W along the section line 1110.47 feet, thence S00°10'45"E 1074.05 feet to the point of curvature of a 67.0 foot radius curve to the left, thence southeasterly along the arc of said curve 104.94 feet (chord S45°03'06"E 94.54 feet), thence S89°55'26"E 74.68 feet, thence S00°04'34"W 66.0 feet, thence N89°55'26"W 74.68 feet to the point of curvature of a 133.0 foot radius curve to the right, thence northwesterly along the arc of said curve 39.83 feet (chord N81°20'38"W 39.68 feet) to the point of real beginning, thence N00°07'19"W 14.42 feet, thence N78°30'10"W 10.60 feet to the point of curvature of a 67.0 foot radius curve to the left, thence Northwesterly along the arc of said curve 13.36 feet (chord N84°12'48"W 13.33 feet), thence N89°55'26"W 12.93 feet to a point on a 133.0 foot radius curve to the left, thence Southeasterly along the arc of said curve 40.90 feet (chord S63°57'12"E 40.74 feet) to the point of real beginning.

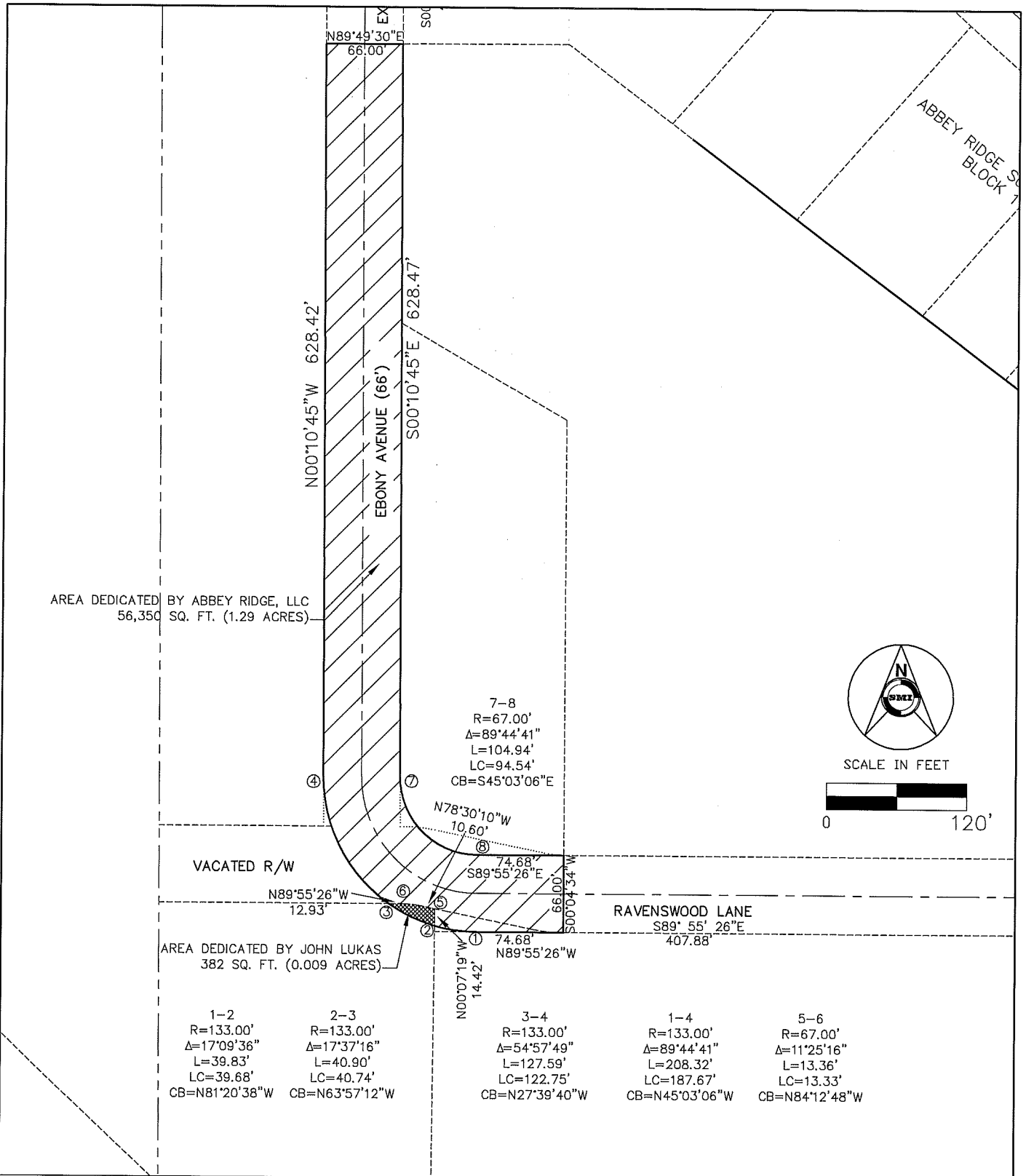

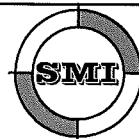

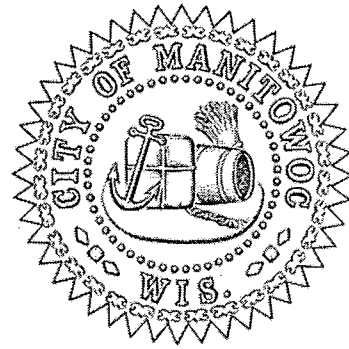
