Dear Public Infrastructure Committee;

On October 19th I received a letter in the mail stating that two of my rental properties had brush on the terrace that was in violation of a city ordinance. This was news to me since I thought the city had Fall clean up for leaves and small branches. I went to both properties the following day (Thursday Oct 20^{th)} to pick up the brush and bring it to the recycling center only to find that the city had already been there and picked it up. My frustrations with this situation are many but here are a few.

- 1. The letter arrived at my house on Wednesday the 19th, allowing me no time to get there and retrieve the leaves and sticks that were in violation.
- 2. Five days from the date the letter goes out is simply not enough time. I don't know if the letter didn't make it into the mail system on the 13th which is the date on the letter or if it got delayed in the mail but I can tell you with 100% certainty that the letter was not in my mailbox on Tuesday the 18th and was in there on Wednesday the 19th.
- 3. What dimension designates a twig, stick or branch? I drove down Menasha Ave on my way to work last week and noticed four properties that were technically in violation of the ordinance. When the leaf crew came through all four violators were picked up by the leaf crews. I drove down the street after they were done and verified.

I'm very frustrated with this whole situation as these were both tenants who were trying to keep nice looking lawns and now we're being punished for it.

I'm politely requesting that I not be fined for the stick pick up at my two properties, 1130 S. 13th St. and 1113 S. 13th St.

If the committee feels the need to follow through with the fines please forward me pictures of the sticks/twigs that were picked up as well as a certified delivery receipt for the violation letter and we will pursue further avenues.


