20-1169 Manty Health & Wellness Center 2021 Agreement and Clinic Services Discussion

Jessie Lillibridge explained to the Committee that the contract with Manty Health and Wellness Clinic is expiring on December 31, 2020. The clinic is planning to increase costs to the City significantly. The City did go out for an RFP, there was one submitted and the City did not accept it. Jay Scott, benefits consultant with USI, gave a bit of a history of the relationship with the clinic and the City to the Committee. USI negotiated with Aurora to help lower the costs in the new contract. Scott's recommendation to the Committee was to accept the agreement as written for 2021 and the City will go out early in 2021 and revisit the RFP and look at an alternative model for the City.

Moved by Sitkiewitz, seconded by Schlei, that this request to enter into an agreement with Aurora for the utilization of the Manty Health and Wellness Clinic for 2021 be accepted and referred to Council. The motion carried by the following vote:
