Dear Board of Public Works:

This letter is in regard to a snow shoveling violation I received on a property at 861 N. 6th St.

Upon receipt of the violation, I contacted Jon, who does all of my snow removal work. He was very surprised, and actually rather dumbfounded by the violation. He told me he had not missed any snowfalls, and had everything cleared off within 24 hours. This is the second year he has done my snow removal work. The first year, I was living in the house, and he did a good job of promptly removing all snow, easily within 24 hours. Therefore, I believe him. He is an honorable man.

As for myself, I am living in Madison. I have not been in Manitowoc since shortly before Thanksgiving of 2019. I spent one week in a hospital. After that, I spent three weeks in a rehabilitation hospital. After that I spent three additional weeks in a rehabilitation facility. Today I live in an apartment, and am confined to a wheelchair.

I have lived in this home in Manitowoc for over forty years. Until two years ago, I took care of all snow removal on the sidewalks of this corner lot. And in those 40 years, I never received any complaint from the city, and certainly no snow shoveling violation.

But now, I am 76 years old, confined to a wheelchair, and unable to live in the two-story house that was my home for over 40 years. I am unable to live in the city I called my home for over 40 years due to my condition and the need for family assistance. I continue to be a responsible property owner, as I always have been, and have retained a snow removal professional to take care of my property and meet city requirements. Receiving this violation was very upsetting to me. It seems unfair to fine a disabled, elderly man who has been an upstanding resident and property owner in Manitowoc for over 40 years. I respectfully ask that you remove the violation and fine from the property.
