14-1222 Vista Road/Custer Street Erosion

The property owner was present to discuss the erosion on the hill and asked if it would be possible for the City to help slow down the erosion by placing rip rap in the area. The homeowner has already planted trees. J. Sladky said we should find out if property owner will allow the City to be on private property. The City staff should contact property owners and look into options and costs.

<u>14-1223</u> Waldo Boulevard reconstruction project alternative designs for Menasha Ave/N. 12th Street

The DOT presented five (5) design options to the Committee and the audience. Discussion ensued with the property owners, business owners, Engineering Staff and Committee regarding their concerns. The Committee was in favor of design option #1. The Committee recommended obtaining accident information for the intersection of N. 11th Street and Menasha Ave.

14-1225 2014 Seal Coating Assessments

<u>14-1230</u> Department of Public Works - Operations Foremen

The Alderman said that they are not opposed; however, they would like some more time to review the recommendation of the working Foremen positions. J. Brey recommended sending in a JDQ at this time. The Committee said they will discuss again in July and will e-mail Dan Koski any questions or concerns.

14-1231 Safe Routes to Schools projected cost estimates

Dan Koski expressed his concern with the amount of staff time involved in this project. The Committee agreed they are not in favor of the additional charges for the project and it is actually costing more than anticipated.
