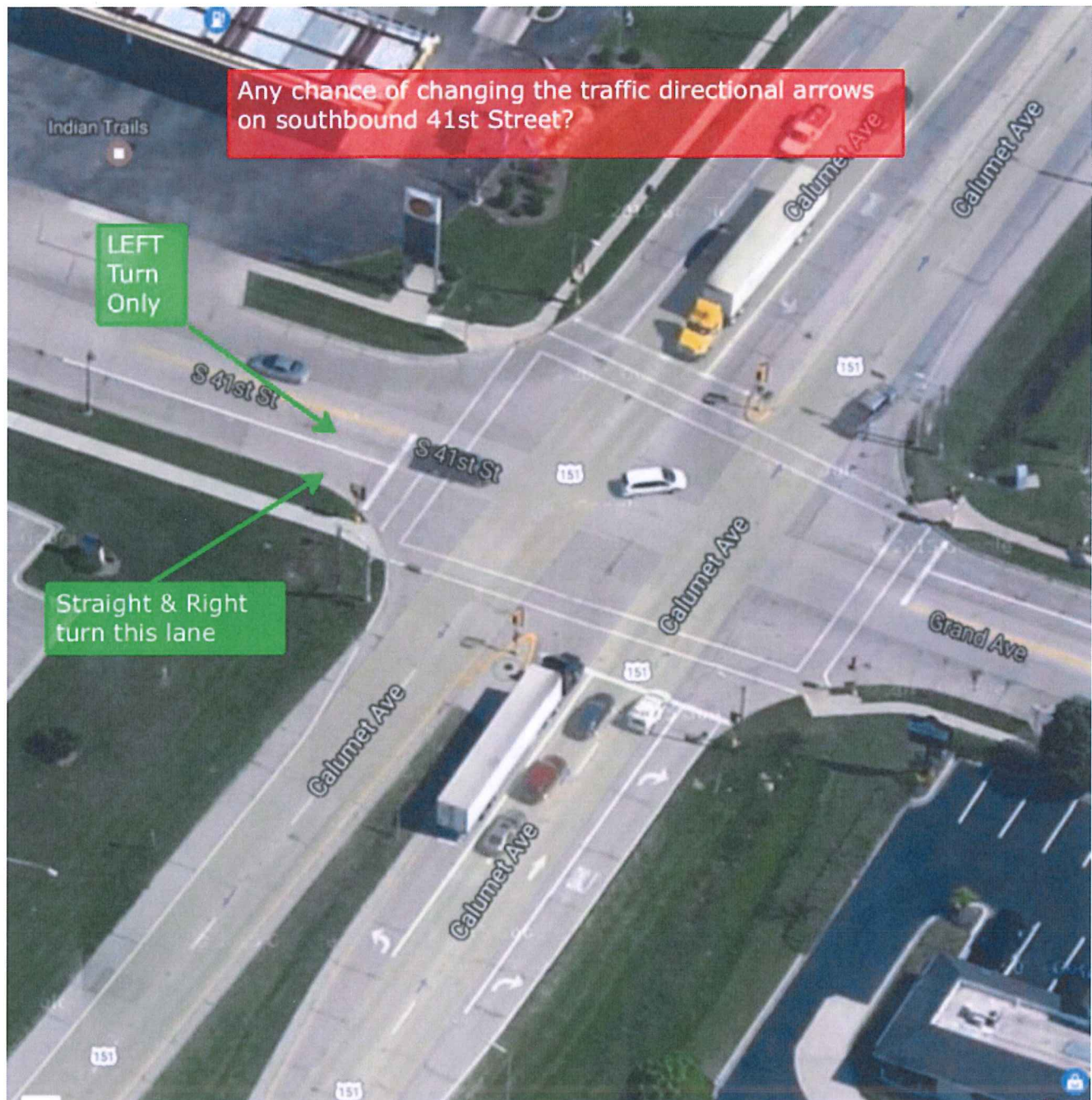

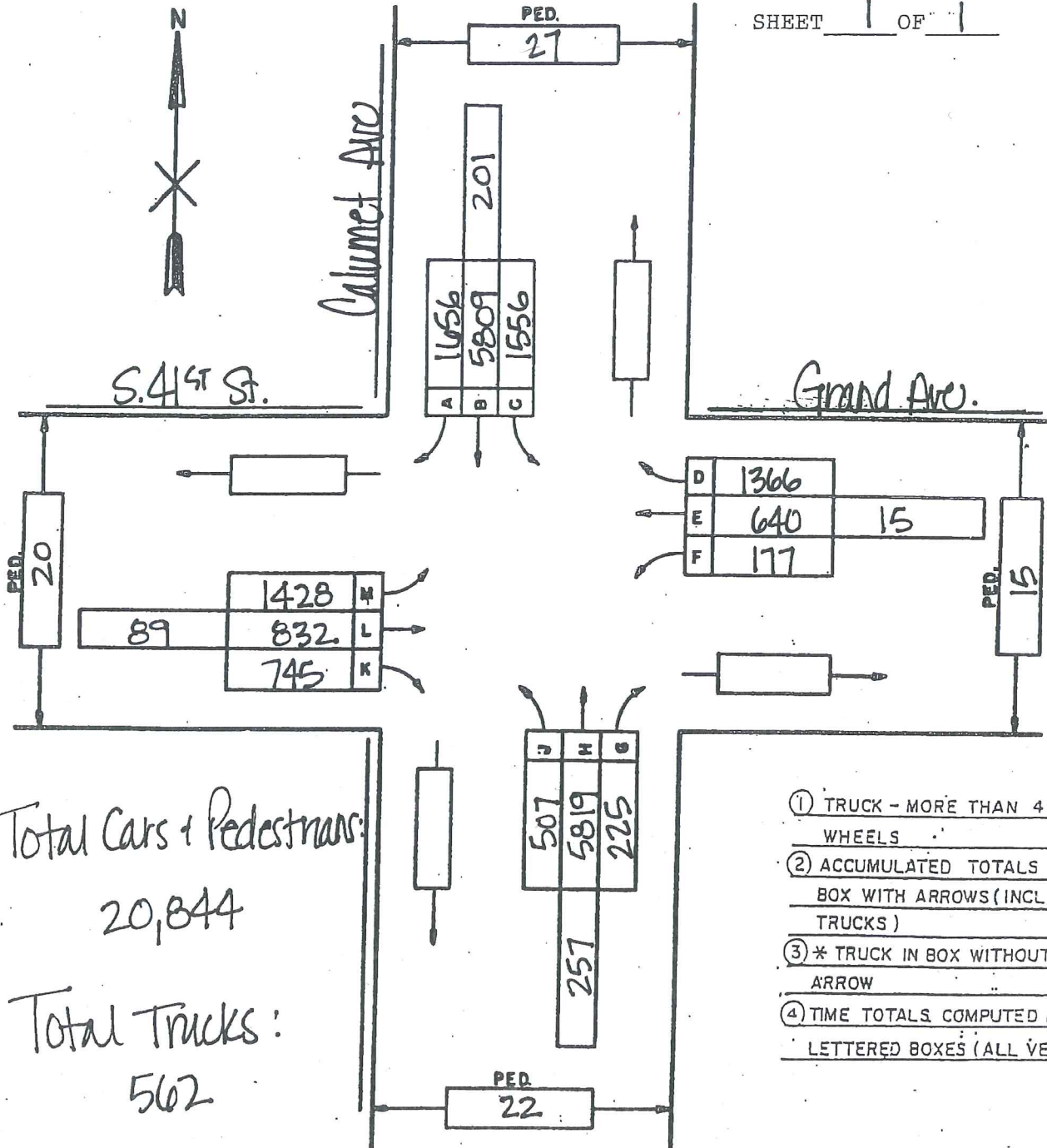

As we discussed, let's send this to the PI Committee for the February 13th meeting. My recommendation would be to only change the one direction or only the S. 41st St. leg of the intersection. There are far too many right turns from Grand Ave. to make the same change on that side.

Prior to the summer of 2014, I do not believe that this intersection had any lane markings.

The PI Comm. approved the current lane use markings in 2014, so I think it is appropriate to bring the request to them to make the change, so if anyone complains in the future we have a paper trail outlining why it changed. Thanks.
