I am enclosing another copy of your invoice for said assessment which is due on November 1, 2020. If not paid it will be included on the first installment of your 2020 property tax bill.

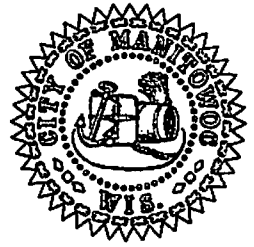


This is the guy who came to the meeting and was not on the agenda. Mackenzie printed off the pictures and it was somewhat discussed (as per the complainant).


