RESOLUTION

WHEREAS, it is in the public interest to vacate a portion of the following described street.

PLANK ROAD: A street vacation in a tract of land located in the SE ½ of the SW ¼ of Section 11, T.19N., R.23E., City of Manitowoc, Manitowoc County, Wisconsin and described as follows:

A road right of way symmetrical about the following described centerline:

Commencing at the Southwest corner of said Section 11; thence N. 89° 16' 44" E. along the section line a distance of 1,317.02 feet to the 1/16th section line; thence. N. 00° 04' 00" W. along said 1/16th section line a distance of 1,119.26 feet to the centerline of Plank Road, also being a point on a 380.0 foot radius curve to the left, the point of real beginning; thence southeasterly along the arc of said curve 62.06 feet (chord S. 71° 40' 42" E., 61.99 feet); thence S. 76° 21' 25" E. a distance of 460.71 feet; thence S. 75° 43' 31" E. (recorded as S. 77° 52' 13" E.) a distance of 333.63 feet to the point of termination.

Said tract contains 31,362 square feet (0.719 acres) of land more or less.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Common Council of the City of Manitowoc that the following street area be vacated:

PLANK ROAD: A street vacation in a tract of land located in the SE ½ of the SW ½ of Section 11, T.19N., R.23E., City of Manitowoc, Manitowoc County, Wisconsin and described as follows:

A road right of way symmetrical about the following described centerline:

Commencing at the Southwest corner of said Section 11; thence N. 89° 16′ 44″ E. along the section line a distance of 1,317.02 feet to the 1/16th section line; thence. N. 00° 04′ 00″ W. along said 1/16th section line a distance of 1,119.26 feet to the centerline of Plank Road, also being a point on a 380.0 foot radius curve to the left, the point of real beginning; thence southeasterly along the arc of said curve 62.06 feet (chord S. 71° 40′ 42″ E., 61.99 feet); thence S. 76° 21′ 25″ E. a distance of 460.71 feet; thence S. 75° 43′ 31″ E. (recorded as S. 77° 52′ 13″ E.) a distance of 333.63 feet to the point of termination.

Said tract contains 31,362 square feet (0.719 acres) of land more or less.

BE IT FURTHER RESOLVED by the Mayor and Common Council of the City of Manitowoc, that the City of Manitowoc and the Manitowoc Public Utilities reserves all the rights, title and interest of any public utility in, on or over the portion of said street to be vacated and reserved to said public utility of the City of Manitowoc.
