- 11. Prepare the Programmatic Section 4(f) Determination and Approval under the Negative Declaration/Section 4(f) Statement for Independent Bikeway or Walkway Construction Projects.
- 12. Prepare a Section 106 Screening List request to be submitted to WisDOT.
- 13. Prepare written comments on the CITY-prepared length of need calculations and drawing for the barrier system at bridge B-36-0035. Preliminary and final designs related to the barrier system will be considered extra services
- 14. Participate in ten phone conference progress meetings with the CITY.
- 15. Prepare the general permit for wetland water quality certification to the Wisconsin Department of Natural Resources (WDNR). Any fees required by the WDNR will be the responsibility of the CITY.
