Hello,

There will be a Downtown/Calumet pickup tonight, Saturday, January 19, 2019 at midnight and continuing into Sunday morning. This will be a one night complete pickup.

PLEASE REMEMBER:

- * Snow must be pushed off of the top of the curb into the parking lane of the street BEFORE midnight tonight. Crews do not pick up or remove snow on top of the curb or on the sidewalk.
- * Please do not push the snow in front of your business along the parking lane into large piles. If you would like to move snow from the curb line before crews begin the cleanup, it should be placed in several small piles, not one large one. Please make sure there is visibility at all corners. Please do not push your snow in front of another business.
- * Snow may NOT be moved from your private parking lot into the street. It is against City ordinance.
