If we do work, say some type of patching, then others may expect the same. As you go north of your house, that pavement is another year or two out and it will look like yours.

Bottom line is it really needs to be reconstructed and that comes with a big price tag for the City and there are numerous streets that are like Kellner.

I would suggest contacting your Alderperson Courtney Hansen and/or the Public Infrastructure Committee Chairman, Jeremiah Novak. Ask him to have the committee discuss it.

The Council recently held a working session with us and we told them that we have about \$40 million in possible street reconstructions.

The mayor has scheduled the Council to do a driving/walking tour of streets but it is not happening until the end of October.
