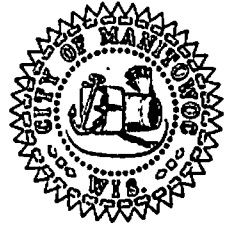

Dear Mr. Stolp:

Your recent communication requesting use of the Farmers' Market parking lot and Library parking lot, closure of a portion of Quay Street, use of various pieces of City equipment, traffic control at S. 8th and Quay Streets, for the 2017 Balloon Glow event scheduled to be held on Friday, August 18, 2017, from 5:00 p.m. to 10:00 p.m., as detailed therein, was acted upon by the Special Events Committee on July 31st.

The Committee granted your request.

If you require the use of barricades or orange cones, please contact the Department of Public Works at 686-6550 prior to 2:30 P.M. between Monday and Friday. For pick up and return of materials, please stop at Department of Public Works office. **If you are closing off a street, you shall provide traffic control barricades.**

For the use of the bandshell, benches, trash barrels, etc., please contact the Parks Department at 686-6518.

The telephone number to arrange for Police Department assistance with your event is 686-6573. Please contact the Manitowoc Fire Department regarding what assistance is needed for the event.

At least 10 days prior to your event, in accordance with City policy, please have your insurance agent submit a certificate of insurance along with additional insured endorsement to my office to evidence your organization's liability insurance coverage. Liquor Liability must also be noted as well as specifically including the bounce house. To expedite, please fax to 920-686-6959 or e-mail to dneuser@manitowoc.org. Special Events Insurance Requirements are also enclosed.


Please stop at the City Clerk's office in City Hall to apply for beer license and/or temporary operator's licenses and contact the County Health Department at 683-4155 to obtain information about a food license.



Set up / take down and clean up, as well as other services provided by a City staff may be billed on a cost-recovery basis. The event organizer must provide a copy of event liability insurance naming BOTH CITIES as co-insured at least 10 days prior to the event. Permits do not allow "exclusive use" of the trail and the general public must be allowed to share the permitted areas.

This agreement is made and entered into by and between the Cities of Two Rivers and Manitowoc, Wisconsin, hereinafter called "City" and the above-named individual, hereinafter called "Permittee." The parties agree as follows: Bookings must be made no earlier than 12 months in advance. The Permittee understands his/her responsibility is to set up, clean up and restore premises within the time period listed above.

Limitation of Use: Permittee agrees that the number of persons on the rented premises during the rental period shall not exceed the capacity of the facility and that no intoxicating liquor or fermented malt beverages shall be served to minors. Permittee agrees to use premises rented for the purpose stated above and no other. In the event this Limitation of Use is not complied with, Permittee shall be charged and agrees to pay a fee of \$200.

Permittee agrees to abide by the rules and regulations contained in this agreement.



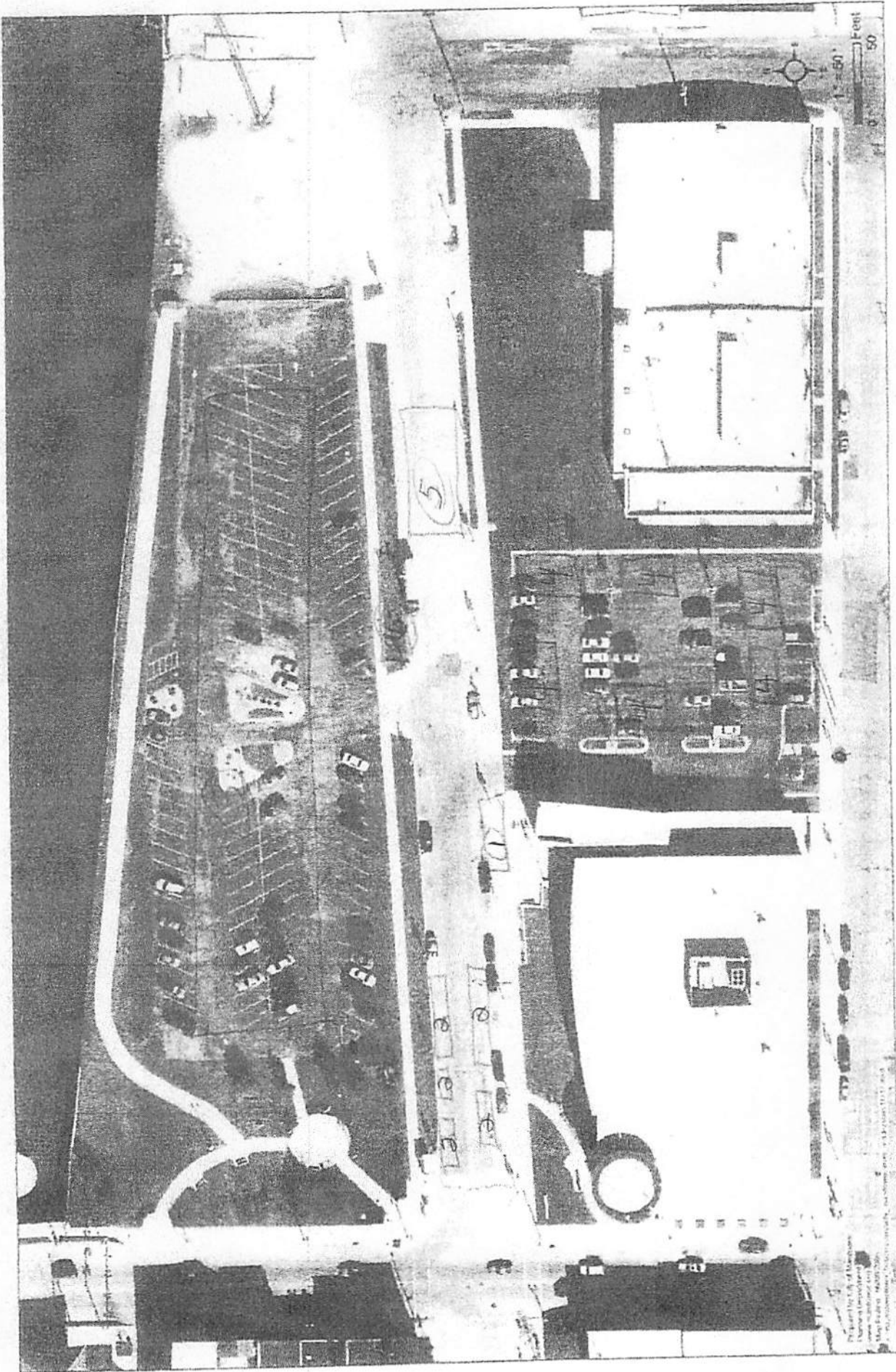
