ORDINANCE

An Ordinance to amend Section 11.010 of the Manitowoc Municipal Code regulating Alcohol Beverages.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 11.010 is amended to read as follows:

"11.010 Alcohol Beverages.

- (12) "Class B" License Regulations.
- (a) Authorized Sales. A retail "Class B" license authorizes the sale of intoxicating liquor to be consumed by the glass only on the premises where it is sold and also authorizes the sale of intoxicating liquor in the original package or container, in multiples not to exceed four liters at any one time, in any quantity, to be consumed off the premises where sold. This paragraph does not apply to a winery that has been issued a "Class B" license.

Section 2. This ordinance shall take effect the day after publication.
