Set up / take down and clean up, as well as other services provided by a City staff may be billed on a cost-recovery basis. Permits do not allow "exclusive use" of the trail and the general public must be allowed to share the permitted areas.

This agreement is made and entered into by and between the Cities of Two Rivers and Manitowoc, Wisconsin, hereinafter called "City" and the above-named individual, hereinafter called "Permittee." The parties agree as follows: Bookings must be made no earlier than 12 months in advance. The Permittee understands his/her responsibility is to set up, clean up and restore premises within the time period listed above.

Limitation of Use: Permittee agrees that the number of persons on the rented premises during the rental period shall not exceed the capacity of the facility and that no intoxicating liquor or fermented malt beverages shall be served to minors. Permittee agrees to use premises rented for the purpose stated above and no other. In the event this Limitation of Use is not complied with, Permittee shall be charged and agrees to pay a fee of \$200.

Permittee agrees to abide by the rules and regulations contained in this agreement.

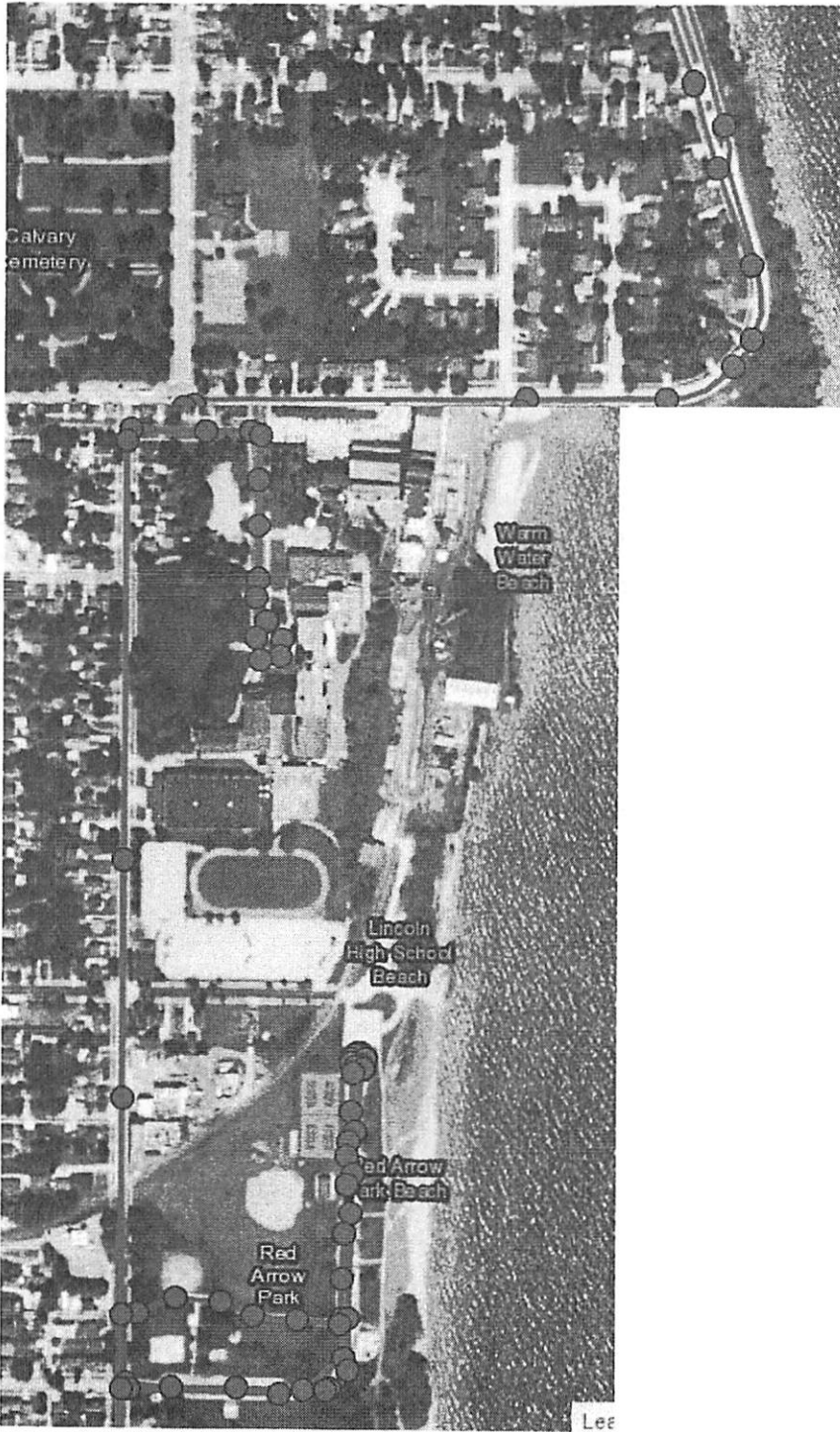

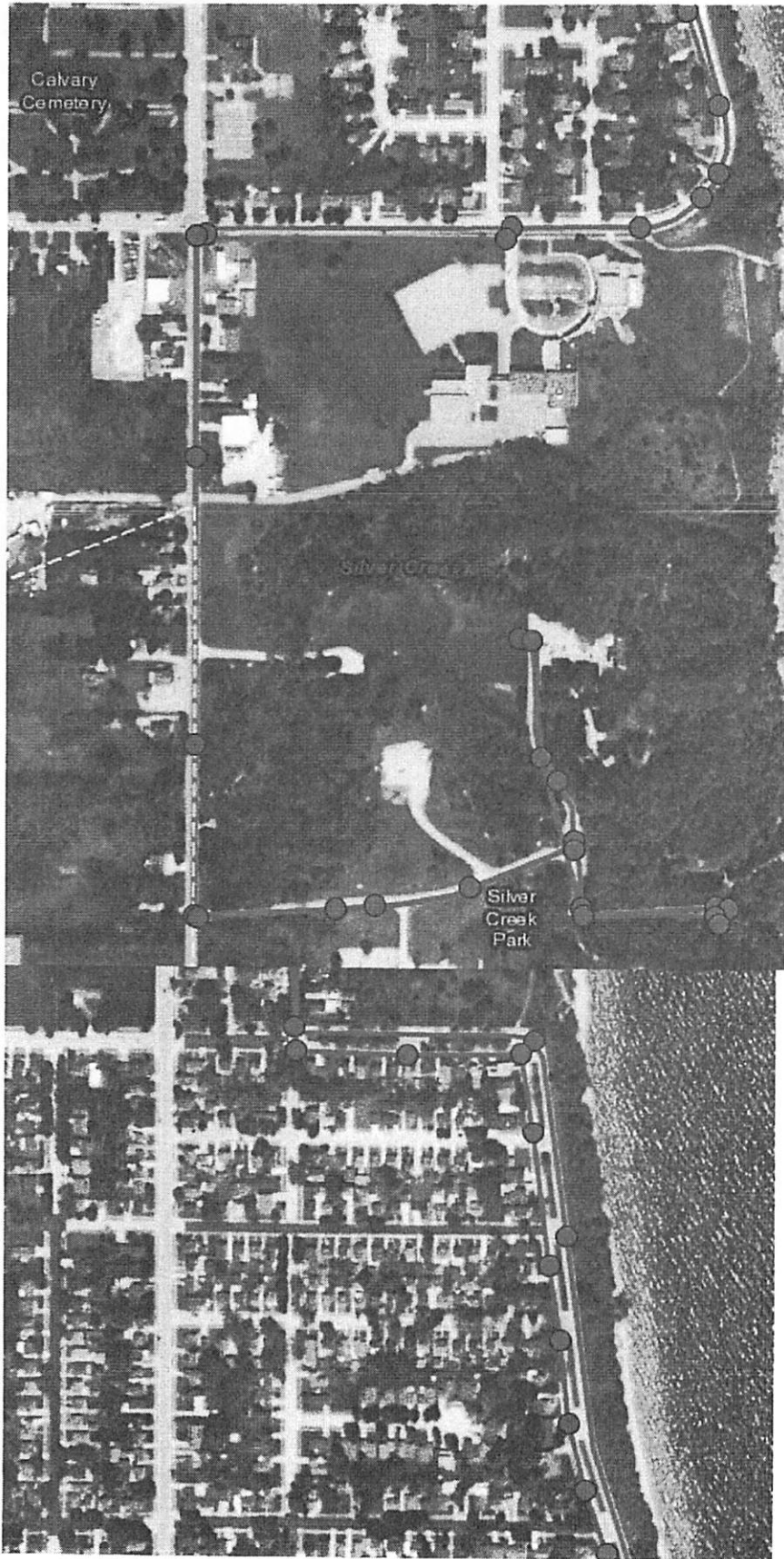

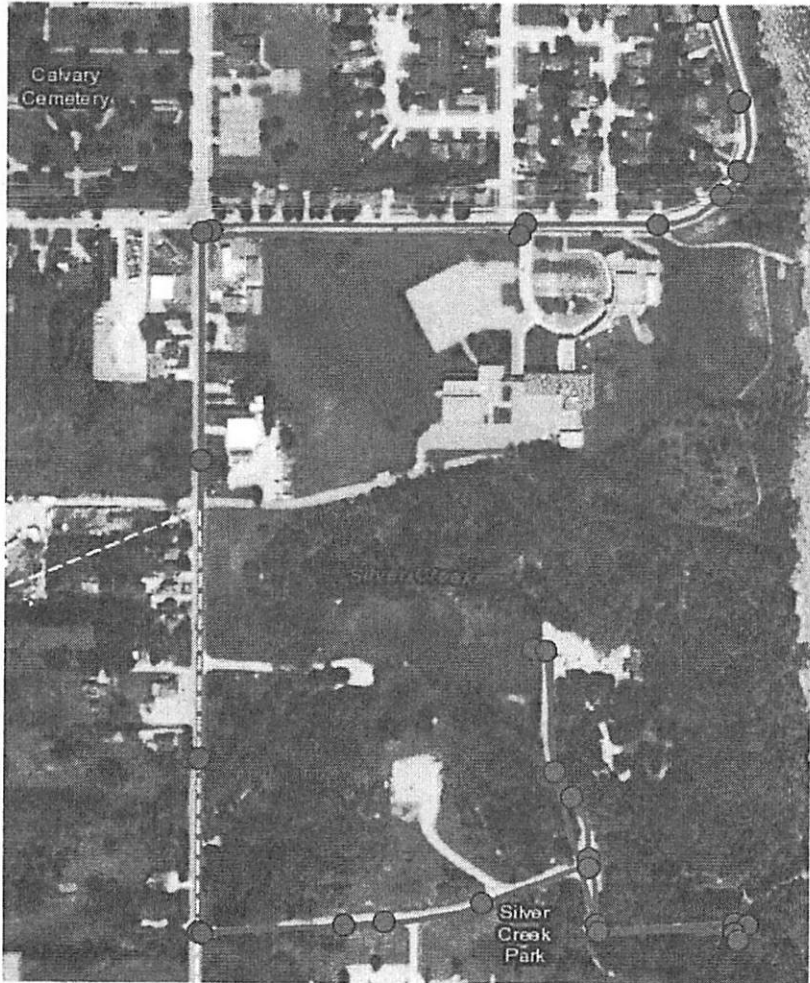

Start around the beginning of the field directly across from the field house.

Follow the road out to 10th.

Right on 10th.

Right on Viebahn and follow to Lakeside Blvd all the way around to Dewey.

Right on 9th.

Right on Jaycee Dr – Red Arrow entrance. Follow the road to the circle/no outlet past the bathrooms and loop back to 9th.

Right on 9th to Columbus.

Right on Columbus up around Lincoln's Circle/Abe and back.

Left on Columbus.

Left on 9th to the small sidewalk that cuts thru Red Arrow Park by the monuments.

At end of sidewalk go left to the circle/no outlet and follow back the road/Jaycee drive to 9th.

Left on 9th.

Left on Dewey and up around Lakeside Blvd to Viebahn. (this could be on the opposite side of the road going back utilizing both sides – just an option).

Left on 10th to Silver Creek entrance.

At the end of entrance over the hill at the fork – go right and follow the first left to go around the loop and back to the starting point.
