Recreation Departments reserve the right to permit events conducted on the Maxiners Trail and facilities. Please complete the following information and submit it to either Parks and Recreation Office. There is no charge for a trail permit, and events will be considered on a case-by-case basis. Considerations for permitting a trail event include type of event, day of event, and other requests within 30 days of the event, as well as other considerations that may affect the public's use of the trail.

All special events or activities approved by the permit panel (Two Rivers & Manitowoc Park & Recreation Directors) can be reserved 12 months in advance including a renewal. "First Right of Refusal" clause. Set up, clean up and take down and other services provided by a City staff will be billed at the hourly rate currently charged by the Park & Recreation Department. Event promoter must provide a copy of liability insurance naming both cities as co-insured at least 10 days prior to the event. Permits do not allow "exclusive use" of the trail and the general public must be allowed to share the permitted areas.

Limitation of Use: Permittee agrees that the number of persons on the tented premises during the rental period shall not exceed the capacity of the facility and that no intoxicating liquor or fermented malt beverages shall be served to minors. Permittee agrees to use premises rented for the purpose stated above and no other. In the event this Limitation of Use is not complied with, Permittee shall be charged and agrees to pay a fee of \$200.

In 2012 the Manitowoc County Sexual Assault Resource Center served 118 clients. Of these clients, 12% were under the age of 12, and 16% were 13-17 years old. In a 2011 report from Manitowoc County Human Services Department, a total of 372 child abuse or neglect reports were made to the agency for physical abuse = 108; neglect = 196; sexual abuse = 60; and emotional abuse = 8.

It takes a community to raise a child, but we would like to add that it also takes a community to protect a child. Everyone one of us possesses superhuman abilities and can help fight evil by supporting child abuse and neglect prevention in our community.

We would like to invite you to unleash your inner superhero for abused and neglected children in Manitowoc County.
