**PROPOSED STREET VACATION AND PUBLIC HEARING ON PROPOSED
CHANGE TO OFFICIAL MAP**

NOTICE IS HEREBY GIVEN that a public hearing will be held, pursuant to Wis. Stat. Section 62.23(6)(c), in the Common Council Chambers of the City Hall in the City of Manitowoc on Monday, August 18, 2014, at 7:10 p.m. for the purpose of hearing any and all interested parties in the matter of a proposed amendment to the Official Map to remove a dedicated right-of-way being an extension to the west of Ravenswood Lane at future Ebony Avenue, and secondly to add a right triangle-shaped area on the east side of Ravenswood Lane at future Ebony Avenue to complete an interior radius curve, as shown in the sketch below.

NOTICE IS FURTHER GIVEN, pursuant to Wis. Stat. Section 66.1003(2) that a resolution providing for the vacation of a .27-acre area of dedicated right-of-way on the west side of Ravenswood Lane was introduced to the Common Council on Monday, June 16, 2014, and will be acted upon by the Common Council at a regular meeting to be held on Monday, September 15, 2014, in the Common Council Chambers of City Hall, or at a subsequent session of the Common Council. The resolution may be adopted as introduced or amended. At the same meeting the Common Council will also act upon the ordinance to amend the Official Map to remove a dedicated right-of-way being an extension to the west of Ravenswood Lane at future Ebony Avenue, and secondly to add a right triangle-shaped area on the east side of Ravenswood Lane at Ebony Avenue to complete an interior radius curve.

Copies of the ordinance to amend the Official Map and the resolution to provide for the street vacation are available in the City Clerk's office.




