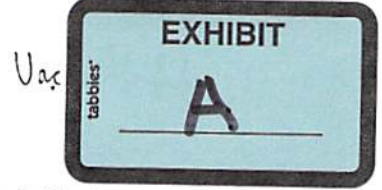

RESOLUTION



Whereas it is in the public interest to vacate a portion of the following described street areas:

That portion of North 40th Street from the South right-of-way line of Delta Street and to the North line of Conroe Street and also that portion of North 40th Street from the South right-of-way line of Ellis Street and to the North line of Delta Street all as recorded in the Manitowoc Rapids Subdivision in the SW 1/4 of Section 24 T. 19 N., R. 23 E., in the City of Manitowoc, Manitowoc County, Wisconsin, all according to the attached maps.

Now therefore be it resolved by the Mayor and Common Council of the City of Manitowoc that the following street areas be vacated, North 40th Street located in the Manitowoc Rapids Subdivision in the Southwest 1/4 of Section 24 Township 19 North, Range 23 East, City of Manitowoc, Manitowoc County, Wisconsin being described as follows:

Description #1

Commencing at the Southeast corner of Block 24 of the Manitowoc Rapids Subdivision located in the SW 1/4 of Section 24, T. 19 N., R. 23 E., being the point of beginning, thence North along the east line of Block 24 a distance of 300 feet to the Northeast corner of said Block 24; thence east along the north line of said Block 24 extended eastward a distance of 60 feet to the Northwest corner of Block 25 of the Manitowoc Rapids Subdivision; thence south along the west line of Block 25 a distance of 300 feet to the southwest corner of said Block 25; thence west along the south line of said Block 25 extended west a distance of 60 feet to the southeast corner of Block 24 and point of real beginning.

Said tract contains 18,000 square feet more or less.

a distance of 60 feet to the southeast corner of Block 27 and point of real beginning.
