**Dev Agreement Strand** 

Community Development Director April Kroner reported on the outside contractor's recommendation of the requested TIF assistance. Ehlers recommended the same amount and structure of assistance as the City originally did, the \$70,000 in assistance with the pay-as-you-go model. City Attorney Kathleen McDaniel provided an overview of the outside legal opinion of the agreement.

Committee and developers discussed request for up-front payment. City Attorney Kathleen McDaniel explained that due to the unique circumstances of this agreement with the potential for conflict of interest, state statues have a maximum amount of \$15,000 per year that could be given.

Moved by Sitkiewitz, seconded by Brey, to enter into the Development Agreement with \$70,000 in pay-as-you-go TIF assistance and referred to Council. The motion carried by the following vote:
