Jeremiah,

I will answer the relatively simple one first regarding signal timing at S. 14th and Washington St.

According to the timing sheet in our files, the north-south (S. 14th St.) movement gets a minimum green time of 10 seconds and if there is a lot of traffic going over the loop detectors, the maximum green time is 30 seconds.

Washington St. is a minimum of 20 seconds of green light with a maximum of 50 seconds of green light.

The timing will likely be different every cycle based on the amount of traffic on each street. This is how it operates when the loops are active.

Mark,

Does this signal run is some coordination phase during the day that has a different timing sequence?? I see some different timings on the coord. sheet (38 sec. and 32 secs. for a 70 sec. cycle length)

If what I described above is not correct somehow, please let us know what the correct timing is. Thanks.

Jeremiah,

Are you suggesting or recommending a yield or stop sign for the S. 11th and Flambeau St. intersection?? Should this be put on the next P.S. Committee meeting agenda??

As for the double signals at Crawford and Rapids Rd. right turn lane, see the attached e-mail. We discussed it and we feel it should be brought to the Public Safety Committee in June or July (whenever we get back to having meetings in the Council Chambers).

Nick,

Dan, Mark and I discussed these signals today and we feel that we should take this to the Public Safety Committee, but we are thinking it might be best if we wait until we can actually meet in person to describe the plan or options.

It might also be beneficial to see if anything changes out here with traffic and pedestrian volumes once the Meijer store and gas station open for business.

We have 2 options. Either replace all 5 of the signals to go with flashing yellow arrows in lieu of the existing green balls or remove all 5 signals and simply install Yield Signs. We would also install additional Yield to Pedestrians in Crosswalk signs.

This situation is not all that different from the right turn lane by Time Out or the right turn lane at N. 18th and Waldo or the Roundabout for that matter.

Should we tentatively look at the July or August Public Safety Meeting to discuss this??
