RESOLUTION

PUBLIC DEPOSITORIES

A Resolution authorizing and designating public depositories.

WHEREAS, § 34.05 of the Wisconsin Statutes provides that the governing body of each public depositor shall, by resolution, designate one or more public depositories, organized and doing business under the laws of this State or federal law and located in this State, to which the treasurer of the governing body shall deposit all public monies received by the treasurer; and

WHEREAS, said resolution shall specify whether monies are to be maintained in time deposits subject to the limitations of § 66.0603(1m), demand deposits or savings deposits or whether a surety bond or other security shall be required to be furnished under § 34.07 by the public depository; and

WHEREAS, § 66.0603(1m) provides that any city may invest any of its funds not immediately needed in time deposits in any credit union, bank, savings bank, trust company or savings and loan association which is authorized to transact business in this state until the time deposits mature of not more than three years; and, § 66.0603(1m) provides for investment in bonds, securities, certificates of deposits and repurchase agreements.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of Manitowoc that the Common Council approve the recommendation of the Finance Committee authorizing the Finance Director/Treasurer for the City of Manitowoc to invest surplus City funds at the following depositories in the following investments up to the following maximum amounts:
