I am dismayed that I received a bill for the tree trimming in 2016, as 3 years have elapsed. My taxes are always paid, and I have ensured the maintenance of my property with local tradesmen as I am a full-time resident in Naples Fl. Since

my relocation here. I have hired local handymen to keep my property in WI in respectable condition. Unfortunately,*, I hired a local handyman that was entrusted to maintain the property and complete the work required, to my misfortune he absconded with the funds and never completed the work. (refer to item 4) As a result, I have incurred \$1200 in additional expenses due to said contractor's fraudulent actions. I have been in contact with several city officials discussing my dilemma, one of the key issues here is the failure to be notified in timely fashion. As you may be aware, I incurred unnecessary expenditures consisting of special violation assessments, should proper notification been effective these bills for the grass cutting would not be an issue. Moving forward, I take great pride in maintaining my property, a contact person in Manitowoc was appointed by myself to act as my liaison. The main issue here is that I would have completed the work had I received proper notification in a timely fashion, I did not receive the five-day notification letter until after the work had been completed.

I have itemized said bills as follows for your perusal

- 1. \$300 bill for grass cutting 2013(5-day notification)
- 2. \$300 bill for grass cutting 2015(5-day notification)
- 3. \$300 bill for grass cutting 2016(5-day notification
- 4. \$300 bill for tree trimming 2016

TREE/BUSH VIOLATION NOTICE

June 16, 2016

TIMOTHY W SCHAUS 3222 KARST CT NAPLES FL 34112

Dear Property Owner:

An inspection of your property at 1235 S 31ST ST (parcel # 370-000-100) has shown that trees/bushes located on your private property are creating a public nuisance by encroaching on the public right of way thereby creating a hazardous environment. The following clearances must be met:

- 1. Clearance above sidewalk must be at least ten (10) feet.
- 2. Clearance above street or alley at curb line or edge of pavement must be at least fourteen (14) feet.
- 3. Bushes must not protrude onto the sidewalk or alleyway from your property. Bushes must be trimmed back to the edge of the sidewalk or to the edge of the alley.

The City of Manitowoc Municipal Code 8.19(7) states that "In the case of an emergency defined herein as a situation which creates an immediate danger or harm to the health, safety or welfare of the public, the City Forester may enter private property to abate a public nuisance without compliance with the notice requirement detailed in this section. If the City Forester shall abate the nuisance on private property, the cost of the abatement shall be reported to the Municipal Tree Commission as a proposed assessment against the property."


Since most property owners prefer to trim/remove their own trees/bushes, we would appreciate your assistance by trimming/removing the affected trees/bushes as requested within 30 days of the date of this notice. If the trees/bushes are not trimmed by this date, the City of Manitowoc Parks Department will complete the trimming/removal as necessary. The costs of the trimming/removal will then be assessed against your property.


