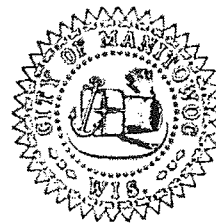

The Manitowoc City Council has stipulated that when an event is held, the person in charge is responsible for getting and returning the barricades with lights. Due to the size and amount of barricades needed to close the street, please make sure you have a pickup truck or trailer when picking up traffic control materials.

Please call the Department of Public Works Streets Division at 920-686-6550 to make arrangements to pick up your items and complete the appropriate paperwork. Please pick up barricades before 2:30 p.m. on Friday, August 17th and return them Monday, August 20th between 7:00 a.m. and noon.

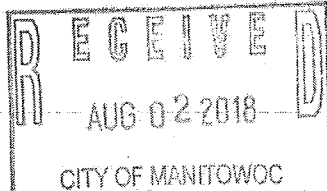

RESIDENTIAL BLOCK PARTY PERMIT APPLICATION

Residential block party permits have a ~~\$25 fee~~ that includes use of traffic control items for the purpose of closing off the street(s). Payment can be made at the time of barricade pickup. Block party hosts must contact all affected residents prior to applying. Block parties must be concluded and the road opened by 11 PM. Any debris must be removed immediately from the street and terrace areas. (Organizations should complete a Special Event Application instead of a Residential Block Party Application.)
