Mr Nick Reimer,

I received you letter stating that the dog "Dozer" is to be removed from the city of Manitowoc pursuant to Manitowoc municipal code14.020(3). In accordance with 14.020(3)a of Manitowoc municipal code14.020(3) I may contest the the order in writing via a letter that states specific reasons for contesting the order.

As such, I, David Kidd, via this two page letter, hereby contest the aforementioned order to remove the dog Dozer from Manitowoc city for the following reasons:

- 1) I have not been found guilty of this incident.
- 2) Chief, the letter that you had delivered to me contained statements and allegations against the dog Dozer that were not true. Had they been true, I would have pleaded not contest, after all, I've never been in this situation before, and I have virtually no criminal record.
- 3) Since the woman Christine Waskow was bitten while attempting to commit what can only be described as insurance fraud for monetary gain (see below for details) neither Dozer nor I are culpable.

The reason that I pleaded not guilty to the dog Dozer not biting the woman in question, Christine Waskow is because this "bite incident" (as this letter will show) was an attempt by Christine Waskow to commit insurance fraud for monetary gain. This is why I have found a lawyer and I am seeking an private investigator. At a minimum, even if I lose my case, she will not be able to do this to someone else.

Yes, Christine Waskow did approach me form behind as I was walking two dogs with a woman who was walking my Chihuahua. Christine Waskow's approach startled the woman, the dogs and me, causing us to all turn towards Christine. Did Dozer lunge? Yes, Dozer lunged but he did not bite this woman. In fact, in this moment, by quickly walking backward, I created 6 feet of space between Dozer and Christine Waskow.

The questions now become how was Christine Waskow bitten, and was it her fault? As stated previously, by quickly walking backward, I created 6 feet of space between Dozer and Christine Waskow. As, I was backing Dozer away, Christine Waskow walked quickly and purposefully to close

the distance between herself and Dozer. She was able to do this because since she was walking forward and I was walking backward, she was obviously able to move faster than I.

Once Christine Waskow was within a foot of Dozer's nose, she turned to her right and then raised her left arm, left hand clinched in a fist. This fist was below her jaw. Essentially she was protecting the left side her body, once her arm was raised, she kept her left arm an inch away from the Dozer's nose as she then began to walk around us. Please bear in mind that I was backing away from Chrisitne Waskow as fast as humanly possible, yet she continued maintain an inch away from Dozer's mouth the whole time. In other words, she wanted to be nipped in her left arm for purpose of insurance fraud.

Like many victims of fraud, I just did not know that fraud was being committed at the time it happened. I only realized that it was fraud after I talked to other people about the incident.

I have walked my dogs along that sidewalk everyday with no problems with joggers and bicyclist.
