One of our traffic control employees (Greg Wuensch) noted that there is currently No Parking allowed on the east side of N. 8<sup>th</sup> St. from Chicago St. to the south for 80 feet plus or minus. This was specifically for the bus stop as faded signage indicated it.

The City bus no longer goes up N. 8<sup>th</sup> St., so we could eliminate the no parking zone and gain 3 additional parking stalls.

The existing ordinance is attached. The recommendation would be to repeal this no parking zone.
