Hi Dave & Jason,

At lunchtime today, I happen to see a JM & Sons truck (Jeff Gulseth) loaded with fill pull into Clay Pit Road.

After lunch, I stopped out there and talked to Jeff and also Al Kubsch. I asked them what they were doing.

They stated that they are building a new parking area for the Chiefs.

I told them that I did not believe that the City Council has approved this work and it was my understanding that any improvements out here require the Council's approval.

Please see the attached 2008 plan that shows what they are planning to do. I also attached 2 photos I took this afternoon.

Al stated that they have a letter from the Railroad granting them permission to use this area for parking. I asked Al to get me a copy of that letter. He said that he would have Dick Orth get me the letter tomorrow.

I told Jeff & Al that I felt that the City Council would support this project, but it still needs their approval and all necessary permits would still be required (Erosion Control Permit for disturbing more than 2,000 SF and a Driveway Permit for the new curb cuts).

We do have at least two concerns. The first concern is the filling of the ditch on the south end. They may need to stub out a storm sewer pipe to pick up the ditch water that will now be blocked by the fill. The second concern is that we will have cars parallel parked on the east side of Clay Pit Rd. and then there will be cars angle parked in the new area right up to the back of curb where the other cars are parked.

We have until 4:30 pm today to get this issue on the Council agenda for Monday.
