We talked on the phone about my taxes and a \$300 charge. I did do a portion of my sidewalk on each side till my blower broke ( 74 Toro which also got stolen since I couldn't move ) I did try to clear until my back went out as I'm disabled, my son said he would come finish but couldn't come till the day after, I did check my door daily for a notice from the city which I never got ( yes I see they changed that but didn't know ) my son came the next day right as it was getting dark and said the neighbor must of did it as it's done, I also asked about snowblower which he said he didn't see. I never got a letter or any info from the city until I saw on my taxes.

There's no way I can pay this as I can't afford taxes or monthly bills as I live on \$1000 a month. Right now I'm 5 months behind on heat and about 4 months on water/electric. I also am trying to save for a roof as it rains in half my house. I started shoving snow when I was 6 in the neighborhood and did that up to 4 years ago. I did the 2 fire hydrants on Mac Arthur and Raton CT & Rasher & Raton. I also did the Alley sidewalk between Rasher & dale a few times every year as they seem to forget. Also had to go back out and open up my sidewalk and driveway on the south and from city guy smashing my snow bank down as he said it's to far in the street which I explained to him it's from Bills Soto that plows into street and pushes on my side because I keep mine plowed to curb.

I'm hoping to make the meeting but still can't find a ride. I thought trying to get a stamp to mail a letter was bad.
