RESOLUTION

HIRING OF KATELIN DOROW AS RECREATION TEAM LEADER

WHEREAS, the Mayor and Common Council approved the reorganization of the Parks and Recreation Divisions of the Department of Public Infrastructure, at a meeting held on September 16, 2019; and the job description for a Recreation Team Leader was approved by Personnel Committee on August 5, 2019; and

WHEREAS, the Common Council enacted an ordinance against nepotism (Manitowoc Municipal Code §20.030) which requires a roll call vote of the Council to approve the hire or promotion of employees related to elected officials, department heads or supervisory personnel.

WHEREAS, the Director of Public Infrastructure was authorized to advertise and fill the newly created Recreation Team Leader position, and has offered said position to Katelin Dorow, who is related to a City supervisor; and

WHEREAS, Ms. Dorow was interviewed one time by a City panel, which consisted of the Director of Public Infrastructure, Human Resources Generalist, Parks and Recreation Division Manager, and Operations Division Manager, and was determined to be the most qualified candidate of the six candidates who interviewed for the position.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of Manitowoc to approve the hiring of Katelin Dorow as Recreation Team Leader, as a full-time, non-exempt employee, effective November 19, 2019.
