

ORDINANCE

An Ordinance to create Section 7.215 of the Manitowoc Municipal Code regulating Removal of Snow or Ice From Streets.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 7.215 is created to read as follows:

“7.215 Removal of Snow or Ice From Streets Prohibited. It shall be unlawful for any person to remove or cause to be removed any snow or ice from any street or alley in the City of Manitowoc without written permission from the Department of Public Infrastructure.

(1). Exceptions. This prohibition does not apply to City residents clearing snow from or around mailboxes or fire hydrants, or to City residents clearing snow from along the curbline of their own property so long as the removed snow is not placed within the street or alley in violation of MMC § 7.210(3).

(2). Penalty. Any person found to be in violation of 7.240(2) shall forfeit not less than \$50 nor more than \$200 exclusive of costs per offense.”

Section 2. This ordinance shall take effect the day after publication.

ORDINANCE

An Ordinance to create Section 7.215 of the Manitowoc Municipal Code regulating Removal of Snow or Ice From Streets.

Section 1. Section 7.215 is created to read as follows:

“7.215 Removal of Snow or Ice From Streets Prohibited. It shall be unlawful for any person to remove or cause to be removed any snow or ice from any street or alley in the City of Manitowoc without written permission from the Department of Public Infrastructure.

(1). Exceptions. This prohibition does not apply to City residents clearing snow from or around mailboxes or fire hydrants, or to City residents clearing snow from along the curbline of their own property so long as the removed snow is not placed within the street or alley in violation of MMC § 7.210(3).

(2). Penalty. Any person found to be in violation of 7.240(2) shall forfeit not less than \$50 nor more than \$200 exclusive of costs per offense.”

Section 2. This ordinance shall take effect the day after publication.
