### FIRST AMENDMENT TO IMPLEMENTATION PLAN FOR PLANNED UNIT DEVELOPMENT (PUD) – CINEMA SQUARE PUD

WHEREAS, an Implementation Plan for Planned Unit Development (PUD) – Cinema Square PUD ("PUD") was executed by Manitowoc Cinema, LLC (MC) and the City of Manitowoc ("City") on August 20, 2013, which document was recorded in the Office of the Register of Deeds for Manitowoc County on August 20, 2013 in Volume 2834, Page 393, as Document No. 1134906; and

WHEREAS, the parties desire to amend the PUD as set forth herein.

NOW, THEREFORE, the parties hereto agree that:

- 1. Article A, Section 2. f. Shall be amended to allow a building to be built to a height not to exceed sixty (60) feet for Lots 1.1, 1.2 and 1.3, measured from the finished grade to the average highest point of the building or structure, with the exception of a single building feature such as a tower, a parapet wall used to shield roof top mechanical equipment and vents, and other communication structures.
- 2. In all other respects, the PUD remains unchanged. Capitalized terms not defined in this amendment shall have the same meaning as defined in the PUD.
