Dear Council Members;

Last week I telephoned the City of Manitowoc with a complaint about an increase in noise from all the Big Rig trucks – those – semi-trailer, tractor-trailer, 18 wheeler trucks as they cross the railroad tracks on Waldo Blvd between North 23rd and North 21st streets.

Canadian National Railroad no longer uses this line and the tracks are out-of-service.

Recently, the noise from the truck traffic has gotten more noticeable. My neighbor, Jon Riser, on North 21st and Kemper, has also commented to me about the noise and rumbling of the trucks and he has heard other neighbors complaining about the noise, so I am not alone in my observation.

I live on Kemper street which is next to the railroad tracks. I took photos of Waldo Blvd by the railroad tracks so you would have a better idea of why I think the trucks are creating more noise.

- # 1 Right by the intersection of Menchl Drive and Waldo Blvd there are two large asphalt road repair patches, one patch has a pot hole the other patch has a man hole cover.
- #2 The railroad tracks themselves have this hard black plastic bumper like material and this material is broken down and in need of replacement or needs to be removed and asphalted over.
- #3 Traffic moves at a faster pace than the posted 30 Mile per hour speed limit and the truckers know the tracks are out of service so no caution is needed and with the road damage just before the tracks along with the broken down black plastic bumper like material by the tracks this all makes for an increase in noise from the trucks.

What can you do to help? Waiting until 2018 for the tracks to be removed would be terrible. Even slowing the trucks down would not stop the noise. The road is caved in around the tracks where the tires roll over and that's what needs to be looked at and corrected.

So I'm hoping you can do something. Thank You.

Hi Dave,

Normally, this type of complaint/issue would be taken care of at our discretion. However, since this is Waldo Blvd. and it is scheduled for 2019 reconstruction, we were looking for the Committee to decide if we should be spending any maintenance funds to make some pavement repairs on a street that is scheduled for reconstruction.

As we all know, there are many other bad joints along Waldo Blvd. This is the only one currently that we have received a complaint on. Our concern is once we fix one, more complaints will roll in.

The rubberized railroad crossing does have some problems, but it appears to me that the bad pavement joints are creating a lot more of the noise that she is complaining about compared to the RR track crossing.

Since this area of the railroad tracks is out of service, I doubt that the railroad is going to be very receptive to doing anything with this crossing.

We should probably keep this item on the agenda, so that the Committee can take action on Ms. Pozoski's letter.




