**Subject:** Unbudgeted Request for CAWG - N. 5th and Pine St. Area

Steve & Kim,

Last night the PI Committee recommended allocating \$50,000 to this project.

We intend to install approx. 7 storm inlets on N. 5<sup>th</sup> St., Lincoln Blvd. and Pine St. (See attached concept plan). There will also be a significant amount of restoration work including curb and gutter, pavement replacement and sidewalks.

The Committee also requested that we televise the storm sewers in this area all the way to the Little Manitowoc River Discharge location.

Our plan will be to get a quote from Vinton and if it appears to be in line with our estimates then we will look at adding this work to one of Vinton's existing contracts as a change order.

We are hoping that this gets approved by CAWG prior to the next Council Meeting on August 17th.

Ald. Brey indicated that he would get the Finance Comm. to approve this during the Council meeting.
