Liz,

On the north side of Quay Street, there will be 2 Electric Vehicle (EV) Charging Only Stalls about 85 feet east of 8th St. and 2 Handicap Parking Stalls about 250 feet east of 8th St. (See attached maps).

For the 2 EV Charging Stalls here are the measurements:

No Parking on the north side of Quay St. beginning at a point located 83 feet east of the east curblineline of S. 8th St. and continuing for a distance of 43 feet, except for the recharging of electric vehicles.

For the 2 Handicapped Stalls here are the measurements:

No Parking on the north side of Quay St. beginning at a point located 242 feet east of the east curblineline of S. 8th St. and continuing for a distance of 43 feet, except for vehicles with Handicap License Plates or an approved and active Permit Placard inside the vehicle.

I guess you may want to come up with better language for the exceptions. I tried to write something.

Fiscal Impact is estimated to be \$600 for new signage and posts.

The budget account line would be the DPI Sign Budget - #1100-32420-536300.
