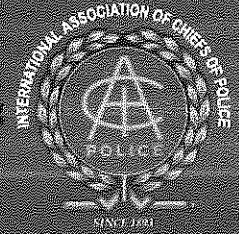
I attached the conference agenda to this request. Please keep in mind IACP still must fill in some of the breakout sessions, but some items to note on the agenda of interest to me are:

**“The Great U.S. Cannabis Experiment: Effects on Driving Is the  
Number One Short Term Consequence.”**

The increased use of cannabis following legalization in eight states and approval of medical cannabis in 28 states has important short-term and long-term consequences for the public. The most important short-term consequence is increased motor vehicle crash injuries and deaths. Interpretation of blood cannabinoid data is complicated by chronic frequent cannabis intake. This problem affirms the important role of the DRE impairment evaluation and markers of recent cannabis intake. The results of the first study of an illicit drug in the world's most advanced driving simulator with and without alcohol, the rapidity of THC decreases in blood after intake, and the relationship between blood THC concentration and DRE evaluations will be presented.
