**Subject: PC 4-2020: Plate Enterprises; Review of a Conditional Use Permit for the Operation of a Recycling Facility located at 1107 Franklin Street.**

At the March 23, 2023 meeting of the Manitowoc City Plan Commission, the Commission unanimously recommended to the Common Council the following action:

***Accept and place on file a letter from Mike Plate, owner of Plate Enterprises, notifying the City that he is closing his recycling business which then terminates a 2020 issued Conditional Use Permit.***

***The Plan Commission also recommends that the Council grant Mr. Plate's request granting him until May 31<sup>st</sup>, 2023 time to clean up the building and process all the current materials on the site.***

We wish to thank you again for your past support, and hope that if Plate Enterprises would like to start doing business again in the City of Manitowoc that you would consider letting us to do so again.

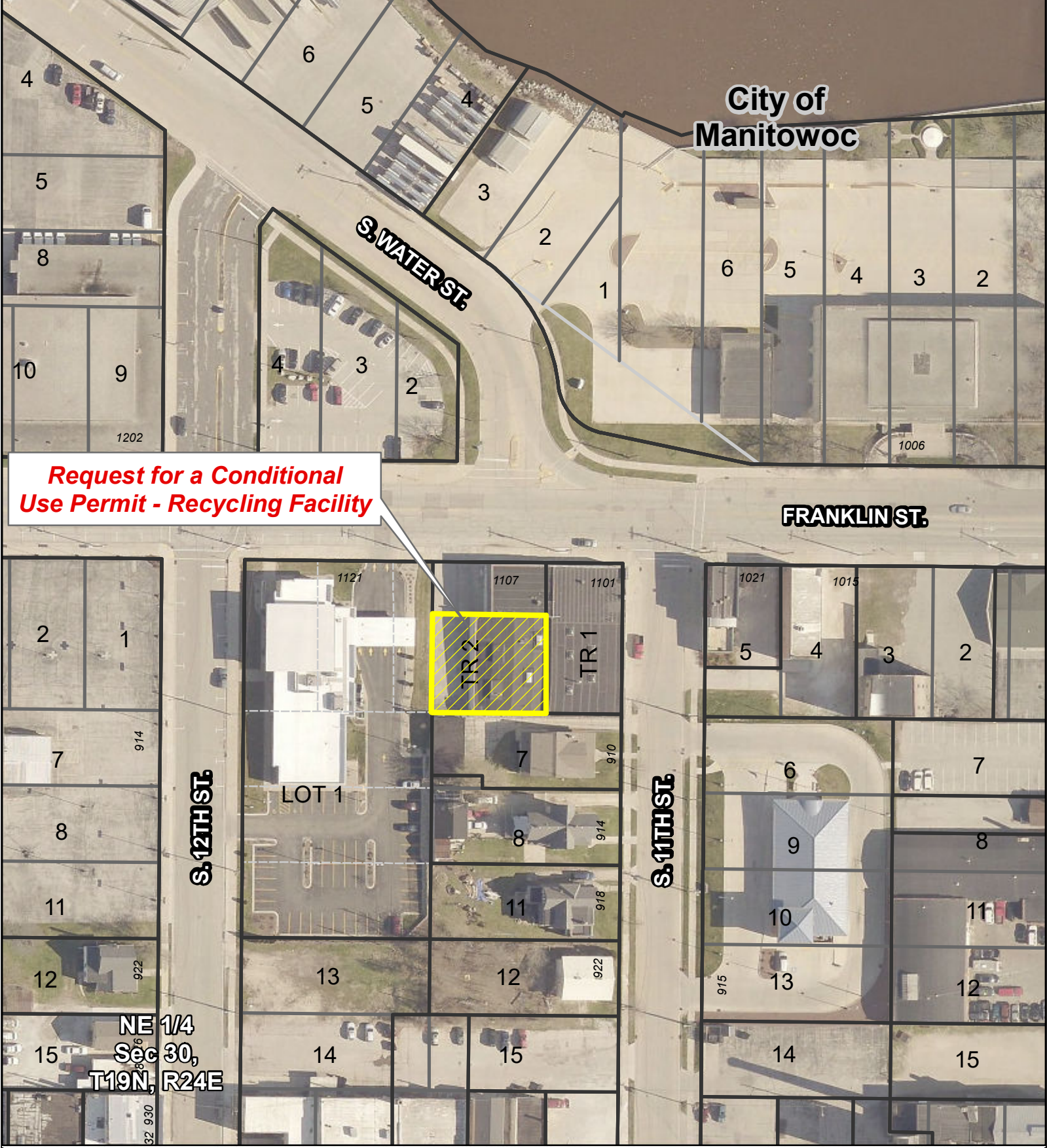

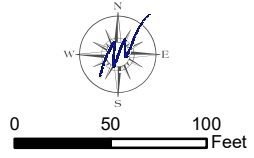


