Pursuant to WIS STATS 75.20(1), tax certificates shall be void after 11 years following December 31 of the year in which such certificates were dated,





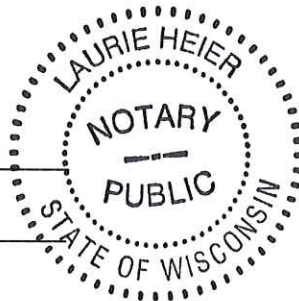
