We hereby submit the following bid for separate proposals to publish for one year, in English, beginning June 1, 2013:

- (a) Council Proceedings and Ordinances we will publish the council proceedings and ordinances in 8 point solid news style in 6 column format at the rate of \$8.04 per column inch.
- (b) Legal Notices we will publish all other legal notices in 6 point solid type in 10 column format and shall be charged at \$.3380 per line.
- (c) Display Advertising we will publish all display advertising in 6 column format at \$8.04 per column inch for the first insertion and \$6.32 per column inch for each subsequent insertion. Ballots will be charged according to the State of Wisconsin Dept. of Administration Guide.
- (d) Ordinances we will print fifty (50) copies of each ordinance at the rate of \$7.50 per every 50 pages printed and delivered.

All rates will remain in effect until new rates are received from the State of Wisconsin Dept. of Administration at the beginning of 2014 at which time they will change according to the rates set by the State.
