### FIRST AMENDMENT TO STORMWATER MANAGEMENT FACILITY MAINTENANCE AGREEMENT

THIS FIRST AMENDMENT TO STORMWATER MANAGEMENT FACILITY MAINTENANCE AGREEMENT (this "Agreement") is dated to be effective as of the 30 n day of June, 2016 by GREAT LAKES ENERGY TECHNOLOGIES, LLC, Wisconsin limited liability company ("Great Lakes"), ORION ENERGY SYSTEMS, INC., a Wisconsin corporation ("Orion"), TRAMONTINA U.S. COOKWARE, INC. ("Tramontina"), and the CITY OF MANITOWOC, WISCONSIN, a Wisconsin municipal corporation (the "City").

RECITALS

WHEREAS, Great Lakes is or was the fee simple owner of the property described on Exhibit A attached hereto (the "Great Lakes Property"); and

WHEREAS, Great Lakes intends to record, or has recorded, the certified survey map attached hereto as Exhibit B ("CSM") to subdivide the Great Lakes Property into two lots to be known as "Lot 1" and "Lot 2", respectively, all as more particularly set forth on the CSM, and has sold or intends to sell Lot 2 to Tramontina; and

WHEREAS, The Great Lakes Property is subject to a Stormwater Management Facility Maintenance Agreement by and between Great Lakes, Orion, and the City, dated December 5, 2008, and recorded on December 12, 2008 in Volume 2424, Page 74, as Document No. 1057567 (the "Stormwater Agreement"); and

WHEREAS, Great Lakes, Orion, Tramontina and the City agree that only Lot 1 should be benefitted and burdened by the Stormwater Agreement and have agreed to amend the Stormwater Agreement to clarify that the Stormwater Agreement only benefits and burdens Lot 1.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and also in consideration of the terms, conditions, covenants and mutual agreements hereinafter set forth, Great Lakes, Orion, and the City agree as follows:

- 1. <u>Incorporation of Recitals</u>. The above recitals are true and correct and form a material part of this Agreement.
- 2. <u>Stormwater Agreement</u>. Great Lakes, Orion, Tramontina and the City hereby acknowledge and agree that (a) only Lot 1 is subject to the benefits, burdens, terms, conditions and obligations of the Stormwater Agreement; and (b) for the avoidance of doubt, Lot 2 is <u>not</u> subject to the benefits, burdens, terms, conditions and obligations of the Stormwater Agreement, and the owner of Lot 2 shall have no rights or obligations with respect to the Stormwater Agreement.
- 3. <u>Conflicts; Further Assurances.</u> In the event of any conflict between the terms and provisions of this Agreement and the terms and provisions of the Stormwater Agreement, the terms and provisions of this Agreement shall govern, control and prevail. The parties hereto each agree to do such further acts and things and to execute and deliver such additional agreements and instruments as may reasonably be required to consummate, evidence or confirm the agreements contained herein.

IN WITNESS WHEREOF, the parties have executed this Agreement to be effective as of the date first written above. This Agreement may be signed in counterparts.


