30 - per week

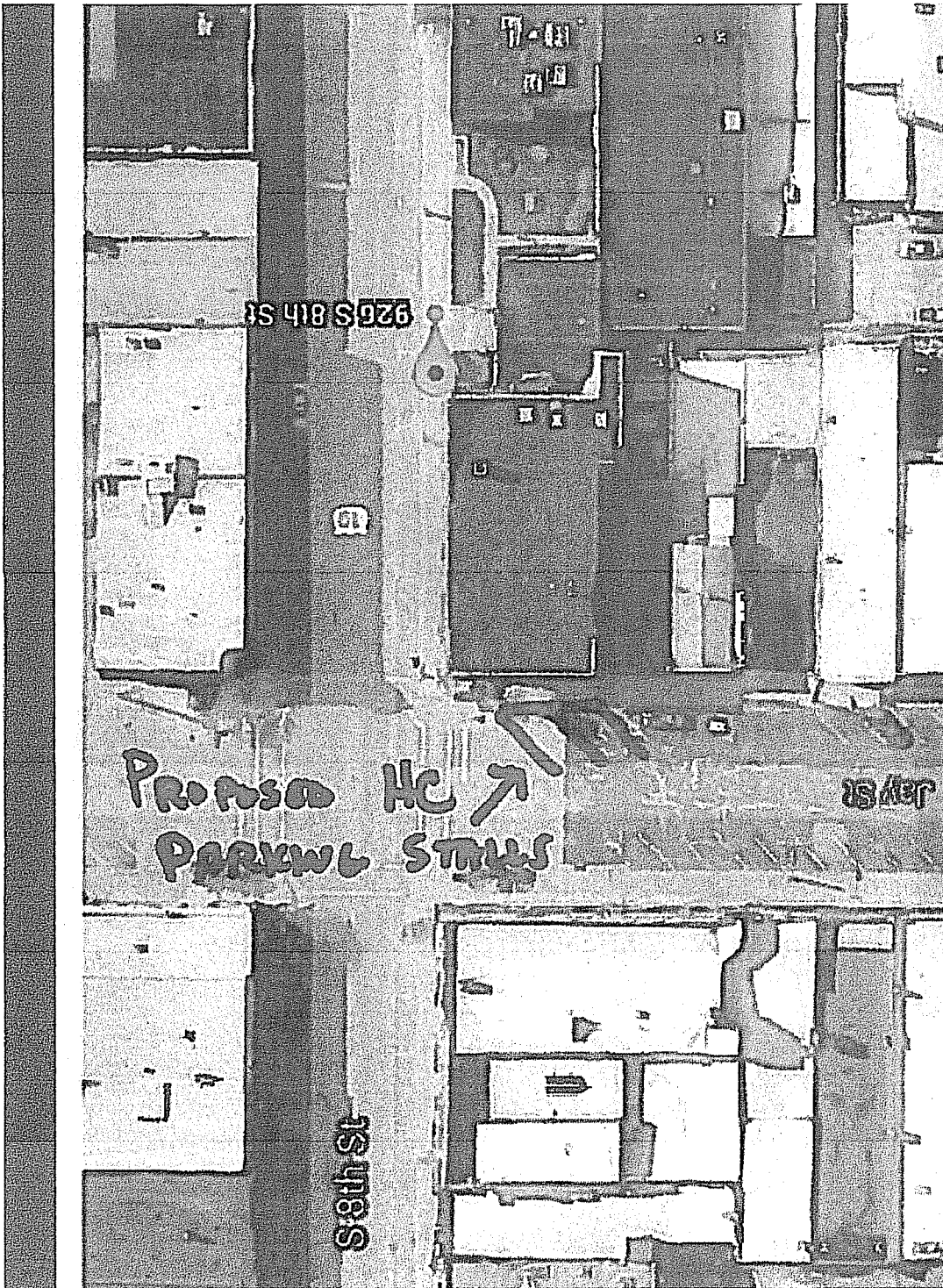
6 - per day
