It appears that we could reditch the north side of Custer Lane to drain into the existing 12 inch pipe to the east of the RR tracks. However, this would require a huge amount of tree and brush removal as well as significant ditching. Not sure how the property owner will feel about this. Maybe we should call or meet them again first.

I have not tried to estimate a cost, but I'll bet we are still looking at about \$10,000 to remove all of the trees and brush and then ditch the area, clean out the plugged 12 inch pipe and restore the new ditch with topsoil, seed and e-mat.



Hi Mike & Ellie:

We have another potential solution to help alleviate the current drainage issues.

The ditch along the north side of Custer Ln. could be re-graded to drain the stormwater from the existing 18" (CMP) culvert at the RR Tracks to the existing 12 inch concrete pipe stubbed out to the ditch. The existing 12 inch pipe is currently buried and plugged with material (See the attached .pdf drawing).

We are not sure what the condition is of the existing 12 inch concrete pipe crossing Custer Ln. Worst case, we would have to replace this storm sewer crossing which would add significant costs, but at least there are some options.

However, this option would require the removal of numerous trees and brush that is located within the Right-of-Way to north of the existing asphalt pavement (see photos #1679 & 1684). Not sure what this would do to your privacy screening that currently exists.

The other big question is who would pay for this work?? I have not tried to come up with a detailed cost estimate, but my first guess would be on the order of \$10,000 or so. Certainly, the cost would be higher if we need to replace the existing 12 inch concrete pipe.

If you are interested in discussing/pursuing this option, please let us know and we can see about adding this to a future PI Committee meeting. Thanks.
