We were notified late last night that the benefit at Digger Dave's, a partnership between them, Pizza Garden and PetSkull Brewing, for Jason and Tina Prigge has grown from just the parking lot between Digger's and Pizza Garden, to hopefully more of a street party with live music and food trucks.
