Ald. Able,

At the December 12, 2016 Public Infrastructure (PI) Committee meeting, a request from the Aging and Disability Resource Center (ADRC) for a new bus stop at N. 17<sup>th</sup> and Michigan Ave. was discussed. The ADRC & Veterans Service Office will be moving to 1701 Michigan Ave. in April 2017. They feel very strongly that a bus stop is needed at N. 17<sup>th</sup> and Michigan Ave. to serve the disabled and veterans. It is my understanding that the Maritime Metro Transit (MMT) plans to create a new stop here beginning sometime in April.

In order for the buses to get back to their original route on New York Ave. the buses will have to drive northbound on North 17<sup>th</sup> St. from Michigan Ave. to New York Ave.

North 17<sup>th</sup> St. is a very narrow street with a curb to curb width of 30 feet.

In order to accommodate the buses, the MMT has requested that parking be removed from the east side of the street.

Can we add this item to the March Committee meeting?
