Hello Shawn

I'm putting in this unbudgeted request for a hot water boiler system at the DPW shop to wash down all snow equipment after snow events. We currently washing all equipment with cold water and have come to the conclusion that we are leaving a lot of salt residue behind and starting the corrosion process very early on in these vehicles life. I have reached out over the summer to other municipalities and vendors to see what there best practice is for washing down equipment after snow events and the one common theme is to wash all equipment with Hot water. Once this hot water system is installed we also plan to add a under body flush system in the floor of the shop down the road. The under body wash would be done in-house by city employees.

I have ever intention to have this hot water wash system available to all city staff to wash off city owned vehicles in the winter months if approved.
