

Please call the Department of Public Works Streets Division at 920-686-6550 to make arrangements to pick up your items and complete the appropriate paperwork. Please pick up barricades before 2:30 p.m. on Friday, August 16th and return them Monday, August 19th between 7:00 a.m. and noon.
