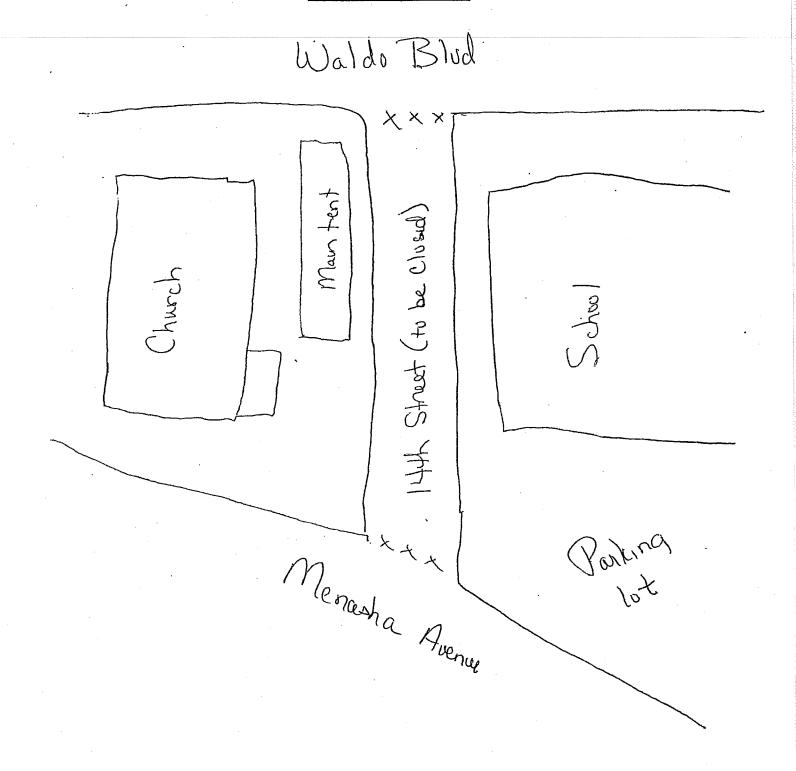

At least 10 days prior to your event, in accordance with Special Event Policy, please have your insurance agent submit a certificate of insurance along with additional insured endorsement to my office to evidence your organization's liability insurance coverage.
