### **ORDINANCE**

An Ordinance to amend portions of Section 10.490 of the Manitowoc Municipal Code regulating two-hour parking in the City of Manitowoc.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 10.490 is amended to read as follows:

# "10.490 Two-Hour Parking.

No vehicle shall be parked for a continuous period of longer than two hours between the hours of 9:00 a.m. and 5:00 p.m., except on Sundays and holidays, on the following streets or portions of streets:

## North 7th Street. Repealed

- (a) On both-sides of North 7th Street from Maritime Drive to York Street.
- (b) On the west side of North 7th Street from Buffalo Street to Chicago Street.

#### South 7th Street. Repealed.

- (a) On the west side of South 7th Street from Washington Street to Franklin Street.
- (b) On the east-side of South 7th Street between Hancock Street and Marshall Street.

### North 9th Street.

- (a) On the west side of North 9th Street from Maritime Drive to York Street. Repealed.
- (b a) On both sides of North 9th Street from York to Chicago Buffalo Street.
- (e b) On the east side of North 9th Street from the Manitowoc River to Maritime Drive.

#### South 9th Street.

- (a) On both sides of South 9th Street from Hamilton Street to Quay Washington Street.
- (b) On both sides of South 9th Street from Quay to Franklin Street.

Chicago Street. On both sides the north side of Chicago Street from North 7th Street to North 8th Street.

Franklin Street. On both sides of Franklin Street from South 7th to South 13-10th Street.

Hancock Street. On both sides of Hancock Street from 9th Street to 10th Street. Repealed.

Jay Street. On both sides of Jay Street from 7 8th Street to 10th Street.

# Maritime Drive.

- (a) On both sides of Maritime Drive from North 6th Street to North 10-8th Street.
- (b) On the south side of Maritime Drive from the west curbiline of North 8<sup>th</sup> Street to the west for a distance of 120 feet.

## Marshall Street.

Approved as to form:

(a) On both sides the south side of Marshall Street between 8th and 9th Streets, Saturdays, Sundays and holidays excluded.

Quay Street. On both sides of Quay Street from South 6 8th to South 10th Street."
