Dear Mr. Koski:

Reference is made to allow the City of Manitowoc, hereinafter referred to as the Grantee, continued access to a portion of the U.S. Army Corps of Engineers (USACE) Federal Navigation Structures at the Manitowoc Harbor Federal Navigation Project, Wisconsin, for ingress/egress access to and from the premises depicted in the attached **Exhibit "A"** for an indefinite period of time, but revocable at will by USACE.

This Letter of Permission (Department of the Army Letter of Permission No. DACW35-9-19-3038) may be accepted as authorization to access a portion of the said U.S. Federal Navigation Structures without charge, per the following conditions:

- a. Department of the Army License No. DACW35-3-03-3001 is now terminated and herein replaced and superseded by the conditions referenced in Department of the Army Letter of Permission No. DACW35-9-19-3038.
- **b.** That the exercise of the privilege herein granted shall be without cost or expense to USACE.
- c. That all activities on the premises must be coordinated with and approved by the USACE Chief of Harbor Maintenance Section and Lake Michigan Project Office. The current chief is Mr. Randall Eigenberger and he can be reached by e-mail at <a href="Randall.K.Eigenberger@usace.army.mil">Randall.K.Eigenberger@usace.army.mil</a> or by phone at (920) 380-7107. The Federal government assumes no responsibility or liability for the technical sufficiency of your construction and/or activity.
- d. That the premises shall at all times be maintained in a good order and clean condition.
- **e**. The Grantee is responsible for the cleanup of any debris or litter placed on the premises incident to the exercise of the privilege herein granted.

- f. Any interference with the use of, or damage to, USACE property under control of the Department of the Army incident to the exercise of the privileges herein granted shall be promptly corrected by the Grantee to the satisfaction of the said chief referenced above.
- g. USACE reserves the right to enter, at reasonable times and in a reasonable manner, upon lands and property owned and/or controlled by the Grantee, for the purposes of inspection, operation, and/or maintenance of the U.S. Federal Navigation Structures.




