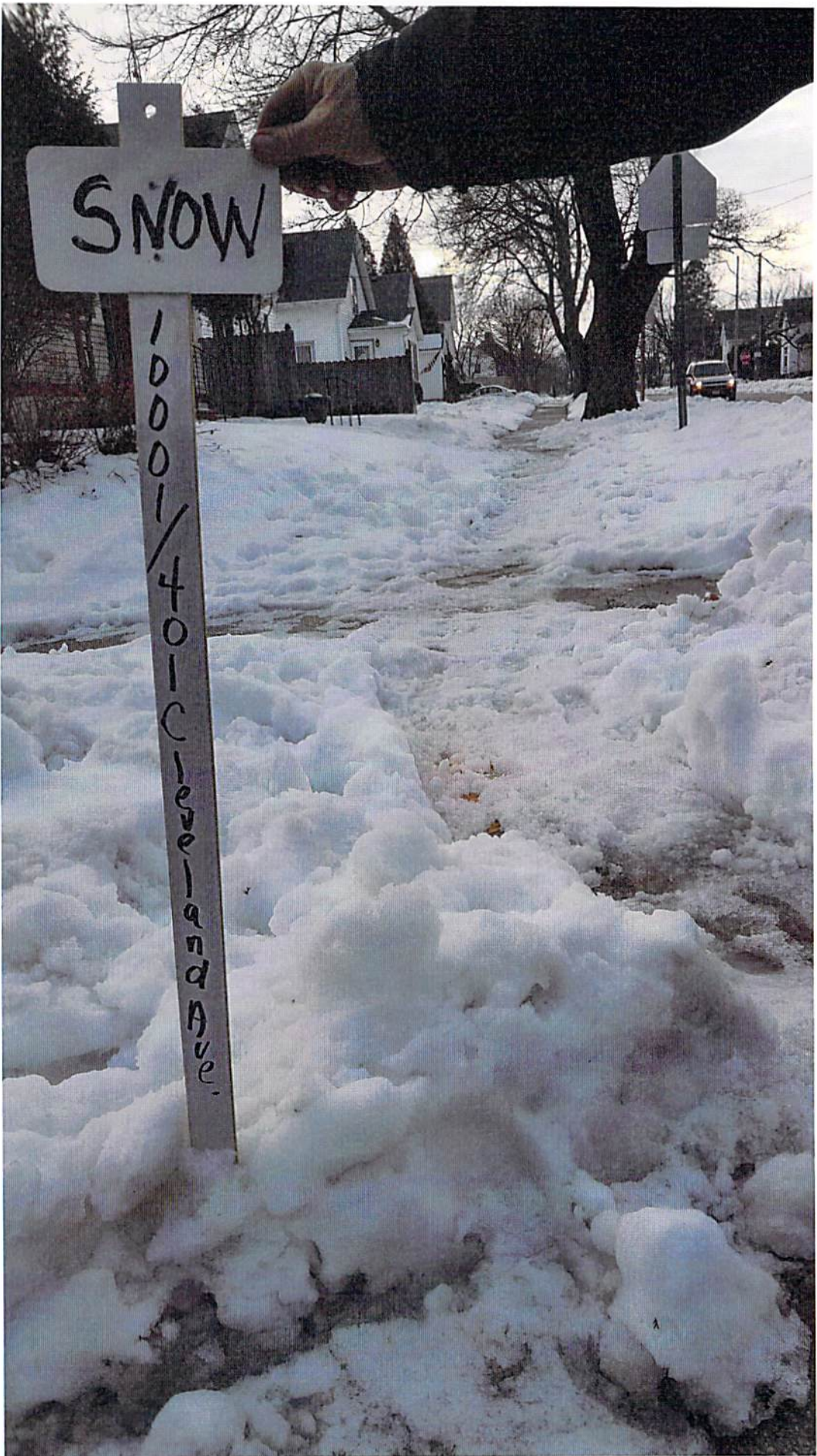
In closing, I feel that these invoices are insensitive in relation to the cause of my absence and subsequent inability to clear the sidewalk of snow.
